Donation to Friends of Fall Creek Watershed will support litter removal efforts

Clackamas, Ore. -- The Oregon Beverage Recycling Cooperative (OBRC), parent organization to [BottleDrop](#), announced a \$2,500 donation to Friends of Fall Creek Watershed. The donation, generated through BottleDrop's [Containers for Change](#) program, will be used by the nonprofit to aid their cleanup efforts along the Fall Creek and Winberry Creek areas.

"This donation will allow us to expand the area of public land that we maintain, give us the opportunity to do more cleanups, and purchase new tools that will help make our cleanups easier, safer, and more efficient."
